FINANCIAL AID:

- Families must apply on time to the ESTF program and to the SJCS FACTS Grant & Aid before the school can determine
 eligibility for additional financial aid. Verification of scholarship or waitlist for the ESTF must be provided to school.
- School based financial aid will only be considered for the portion of **FACTS Grant & Aid-determined need** that exceeds the **\$7,634 ESTF scholarship amount.**
- If a qualifying family does not receive the ESTF scholarship (verification of waiting list must be provided to the school), they remain eligible for all applicable tuition discounts and may be awarded school-based financial aid based on their FACTS Grant & Aid-determined need, subject to availability. Funds are limited and qualifying for an amount does not guarantee that the full amount will be awarded.
- The school will base aid decisions **solely on determined financial need**, not on how a family chooses to allocate their ESTF scholarship.
- All scholarships are applied to the **full published tuition rate first**, then any applicable discounts are applied to the remaining balance (sibling discount and parish discount).
- At no time will the school issue cash refunds for ESTF scholarships.

TUITION PAYMENT OPTIONS:

Option A	Single Lump Sum Payment due by August 15 th (2% Discount)
Option B	Quarterly Installments due Aug 15 th , Oct 15 th , Jan 15 th , and April 15 th (1% Discount)
Option C	Twelve Monthly Installments (July 2025 – June 2026) drafting on the 15th

Financial Aid recipients do NOT qualify for payment discounts in A or B. Student fees are not discounted.

Withdrawal Policy: Any family withdrawing after the contract begins will be obligated to pay the entire student fee amount and the following month's tuition.
